 Subject: New Minimum Satisfactory Progress Requirements; Student Intent to Transfer Certificate

I want to remind you of a couple of significant eligibility issues that your students need to be aware of as the 2014-15 school year winds down:

1. **Satisfactory Progress Toward Graduation**

In April, the OSAA Delegate Assembly adopted changes to the Minimum Satisfactory Progress Requirements that all students need to meet beginning with the 2015-16 school year:

All returning students who do not meet the Minimum Satisfactory Progress Requirements shown above need to enroll in and complete a credit recovery program this summer in order to regain (or attempt to regain) their eligibility. Students who are not "on track to graduate" are not eligible to participate in the 2015-16 school year.

2. **Student Intent to Transfer Certificate**

At this time of year, there are many students and families making plans to transfer for the 2015-16 school year. Students who intend to transfer to or from your school need to complete the "Student Intent to Transfer Certificate" prior to receiving any athletic instruction from anyone associated with the new school. This form must be completed, signed by an administrator from both the sending and receiving school, and be on file at the new school prior to receiving any athletic instruction or participating in any summer programs at the new school.
